

# Core Online ICS Training Courses

The overarching goal of these foundational training courses is for participants to begin an important educational journey - one that will contribute to improved patient experiences, access to health services and health outcomes for Indigenous people.

These courses are facilitated by a trainer who supports participants' learning along the way. Both include the same six core modules, plus an additional two modules that are specific to health or mental health. There is no prerequisite for taking either of these core trainings.

## Ontario Core ICS Health

This course is designed for everyone working in Ontario's health system, including leadership, administration, and allied health professionals. It focuses on issues that are specifically relevant to providing health services to Indigenous people in Ontario. Learning is self-paced over an eight-week window and typically takes between eight and sixteen hours to complete, though this could be longer or shorter depending on your style of learning.

## Ontario Core ICS Mental Health

This course is designed for professionals working in mental health and addictions, and/or social service settings. It focuses on issues that are specifically relevant to providing mental health services to Indigenous people in Ontario. Learning is self-paced over an eight-week window and typically takes between nine and seventeen hours to complete, though this could be longer or shorter depending on your style of learning.

### Accreditation
